NYS RELEASES CREEDMOOR CAMPUS MASTER PLAN

On December 6, 2023, Empire State Development held a webinar to present the Creedmoor Community Master Plan. The plan calls for over 2,873 residential units on 58 acres of the Creedmoor campus. It is available for review at creedmoor.nyc.

Note that 1,633 of these units are designated for home ownership, while about 1,240 would be rental units. The rental units would be in buildings from 6 to 8 stories in height, and would include 377 units for senior citizens, 431 for supportive housing and 432 affordable units awarded by lottery. Veterans would get preference for 15% of the rental units. The 1,633 units proposed for homeownership would occupy a range of building types: 813 units in elevator coops six to eight stories; 536 units in walk-up co-ops three to four stories; 186 three-story triplexes and 98 semi-detached two-family homes. The rate of home ownership in the development is far less than the percentage of home ownership in Community Board 13. This begins to change the nature and character of our community.

A parcel of land would be made available to the Dept of Education for possible construction of a K-8 school. Plans also include inclusion of small to medium sized businesses and a senior center. The main concern expressed by members of local civic associations is that the density of the project as proposed would have an adverse impact on the community. Queens Community Board 13 Chair Bryan Block has established a sub-committee of the OCB 13 Land Use Committee to address the Creedmoor Community Master Plan. The 22-member subcommittee is comprised of local leaders and Community board 13 members from Bellerose, Queens Village, Floral Park, Glen Oaks, Cambria Heights, Laurelton, Rosedale, and Springfield Gardens. CCA President Mike O'Keeffe and Treasurer Jim Trent are on the sub-committee. At the subcommittee's first meeting on December 19, members from all over QCB 13's catchment area said they moved to their community for its suburban quality. The consensus was that the project needs to be scaled back.

We will be focusing on this issue for the foreseeable future.

Farewell to Inspector Igor Pinkhasov, who served as 105th Pct Commander for over three years. Welcome to Captain Sony Beauvoir the new Commanding Officer of the 105th Pct. Captain Beauvoir has served as Executive Officer for several months and has a good understanding of the precinct.

There have been at least two car thefts in our area in the past month. If your vehicle has a key fob, keep the fob in a metal box or Faraday box or pouch so that thieves can't activate the fob remotely. The use of a steering wheel or brake pedal lock may deter conventional auto thefts. There was also at least one theft of a catalytic converter, taken overnight from a 2014 VW parked in the owner's driveway.

Sector David and Sector Eddie held quarterly Build the Block meetings in December. A few highlights:

- There was a "skimmer" found on an ATM machine in a 7/11 on Hillside Ave. Thieves attach skimmers to ATM's to obtain information from bank cards. Make sure a device is not attached to an ATM before using it.
- Burglars pushed in a window air conditioner to gain access to a house in Sector Eddie. Consider removing window air conditioners during the colder weather. They are easy for burglars to push in.
- Consider carrying your credit cards in a "Faraday sleeve." Thieves can obtain information from credit cards we carry around.
- Scams: The IRS will not call you. And, if you get a text message about a package, don't click on the link. It's probably a scam.
