BELMONT CASINO'S LUCK RUNS OUT

Floral Park and surrounding communities are celebrating the decision not to place video terminals at Belmont racetrack.

The opposition has prevailed. There will be no casino at Belmont Racetrack.

Under terms included in the recently enacted New York State budget, Nassau County will transfer the rights to install 1,000 video lottery terminals to the Resorts World Casino on the Aqueduct Raceway property in Ozone Park. In return, Nassau County is scheduled to receive \$43 million over the first three years.

Opponents of the Belmont casino mounted a vigorous campaign to defeat it. Community Board 13 passed a resolution against the casino. Matt Sexton from the South Side Civic Association in Floral Park spoke against the casino at our March meeting.

Questions remain about how the Belmont property will be developed. One proposal calls for a stadium to be build for the Cosmos soccer team. Another question is whether the increased gambling at Aqueduct will have a negative impact on Ozone Park and other nearby neighborhoods.

MOSQUITO SEASON UPON US

With the arrival of spring, mosquito season is not far behind. Although it is not clear that mosquitos infected by the Zika virus will reach New York, West Nile virus is always a threat, and mosquitos are a real nuisance in our community. Do your part by eliminating any standing water where mosquito larvae can breed. This includes pool covers, upturned garbage can lids, flower pots, and clogged gutters.

NEW STREET LIGHTS RAISE CONCERNS

As mentioned in our March newsletter, the street lamps with new light-emitting diode (LED) bulbs make the street brighter, but cast very little light on the fronts of our homes. This might be a good time to consider upgrading your outdoor lighting. A few suggestions from your neighbors:

Lights with LED bulbs are brighter and use less electricity. One possible problem is that the light might be too bright for some people. Discuss the type of light and its location with your next door neighbor.

A light on the garage could light up your back yard and driveway at the same time.

Timers and motion detectors are possible ways to control lights. Some people believe that motion detectors can perform erratically.

At a recent meeting, Martin Van Buren High School Principal Sam Sochet reported that the MVB Robotics Team finished 12th out of 66 teams in a competition at the Javits Convention Center, beating Bronx Science and Thomas Edison HS.

NOTES FROM THE 105 PRECINCT

Deputy Inspector Jeffrey Schiff, the new Commanding Officer of the 105th Precinct, conducted his first community council meeting on Wednesday, March 30. He is a 20 year veteran who grew up in Bellerose and Glen Oaks.

DI Schiff said that police officers and community members are partners. He reminded us to call 911 if we observe suspicious activity. There will be a new email address to report information to the police: 105precinct@nypd.org. DI Schiff reported that there were 32 burglaries in the precinct in the past month, up from 25 during the same period last year. Ten burglaries took place in the satellite area in the southern part of the precinct, while 22 occurred in Bellerose, Floral Park, Glen Oaks and Queens Village. Several of these were burglaries of garages, for which several juveniles were arrested.

DI Schiff stated that most burglaries of private homes take place through the side and rear doors. NYPD officers don't patrol on private property, so they rely on information from the public. Exterior lighting may be a deterrent. Assaults also increased. Many assaults were domestic violence incidents, 70 percent of which were for first time offenders. DI Schiff hopes to address this issue through community education. Twenty-one robberies took place throughout the precinct, resulting in 8 arrests.
