# PROPERTY TAX HIKE WORSE THAN YOU THINK!

By now you all know about the 18½ percent increase in real estate taxes. But you might not realize that this isn't the whole story.

Real estate taxes are not apportioned equally. There are classes of properties and we all know that homeowners get a break. Utilities do not. Since they are permitted to make a certain amount of profit, expect that their tax increase will be passed on to the ratepayers: that's you. Wait, it gets worse. You've read how there hasn't been a real estate tax increase in a decade. Well, yes and no. Taxes are based on the value of the real estate, and real property values have been skyrocketing for the last number of years, so we've been paying an increase each year anyway. On top of that (you thought we were finished?) because of the law passed some years ago to require the equalization of taxes paid by new homes compared to old homes, there is another upward adjustment made to the taxes of about 6%, so expect your

taxes to go up much closer to the 25% the mayor had originally requested since most of us live in homes built in the 1920s.

Was your civic association's voice heard on this issue? Was anyone's voice heard on this issue? There were no public hearings. This was a closed door maneuver, called a budget



modification. It didn't require Albany's approval either, that's why it was seized upon as the tax increase of choice.

Absentee landlords will be charged a higher rate than owneroccupied properties. That's the only good thing about the tax change. This change has been supported for years by civic groups as a way of discouraging absentee-landlords because they generally do not maintain properties as well as people who live where they own.

It was decided by the powers that be that a tax increase was preferable to service cuts. That's debatable. There are a lot of questionable services provided by the City, and no matter what anyone says, the City's payroll can be trimmed without damage to those services if it is done selectively, and not across the board. This increase is on top of fees and fines that the City has just raised, and still to come are increases in bridge/tunnel tolls and subway/bus fares.

Most of the City Council voted for the increase, and it can fairly be stated that many felt there was no way out. However, six councilmembers voted no, and according to the *New York Post*, may suffer retributions in the form of lost perks (member item money?) and even having their districts cut up in re-apportionment, though it seems the lines have largely already been created. What is the point in having 51 councilmembers if they are all required to vote as one? Why is this voting system more legal than the Board of Estimate? A government which invests so much
