## FOLKS GET ROWDY AT WEPRIN MEETING

Some 400 residents turned out for a December 16th town hall-style meeting convened by local councilman David Weprin. There was screaming, shouting and carrying-on the likes of which have not been seen at a civic meeting in many years. The residents were venting their frustrations at the representatives of the Departments of Buildings and City Planning.

Some even vented their spleens at Weprin himself. At one point, Weprin called the police to insure that no violence took place, but that was probably overkill. While angry, this group which included virtually every civic leader in the 23<sup>rd</sup> Councilmanic District, was not likely to start throwing furniture around. But they were mad as hell and weren't going to take it anymore.

As part of the aftermath of the meeting, Weprin staffer Arthur Flug resigned. The meeting was held in the auditorium of M.S. 172 in Floral Park. The Queens DOB commissioner Magdi Mossad, and the chief of the Queens Office of City Planning, John Young, were the special guests. Nothing gets Queens people more worked up than issues regarding inappropriate zoning which is causing sound housing in beautiful suburban neighborhoods to be bulldozed, and the lack of enforcement of the Building Code by the Department of Buildings.

The cartoon at right which has been making its way around the Internet is typical of the public's contempt for the DOB.

While some City Planning has achieved some recent downzonings, other neighborhoods are still waiting and the process is way too slow. Many neighborhoods are being lost while the process makes its way. The Landmarks Commission is also under fire. They have nothing but disdain for Queens and repeatedly refuse to move in any meaningful way on landmark districts for Queens. They've turned down Richmond Hill twice and just recently rejected Douglaston Hill with its beautiful turn-of the century Victorian mansions. But the DOB probably frustrates Queens people the most. No matter how outrageous the alteration, DOB seems to find



some way to find the change legal. And when there *is* agreement on the illegality, nothing is done to reverse the change. Illegal buildings are never torn down. And it didn't help that Mossad's thick accent made his answers to the people's questions almost unintelligible. As we've reported in the past, one plan to deal with the problem is to reorganize the DCP and DOB and put the borough offices under the Borough Presidents who would be more accountable.
