## BELLEROSE REZONING PUBLIC HEARING SET FOR MARCH 12

As we have reported previously, the Department of City Planning has been working on a rezoning plan for the Bellerose, Floral Park, New Hyde Park, Glen Oaks and Royal Ranch communities.

During the past 2 years, planners have canvassed over 400 city blocks in these areas. The purpose of the rezoning study was to determine the primary usage of each block, then adjust the zoning as necessary to allow reasonable development while preserving each neighborhood's character.

As the next step in the process, Community Board 13 will hold a public hearing on the rezoning on Tuesday, March 12, 2013 at 7PM at the Bellerose Assembly of God Church, located at 240-15 Hillside Ave. Residents are encouraged to attend to learn more about the process.

Thanks to Council Member Mark Weprin, Chair of the City Council Zoning Committee, for his work on behalf of this initiative. Thanks also to State Senator Tony Avella for his assistance and support.

#### SEWER & WATER MAIN INSURANCE UPDATE

There has been a lot of interest in the recently announced insurance program for water and sewer lines.

In order to get as many answers as possible we used the following sources:

- DEP and Americal Water Services (AWR) literature, including AWR NYC Sewer Service Line Protection Program Terms and Conditions
- Telephone conversations with AWR representatives

- Articles from local newspapers
- Conversations with other civic leaders.

**Note:** We believe this information is as accurate as possible. Before making a decision, you are advised to verify the information or contact AWR with any other questions you may have.

#### Sign up:

Interested homeowners may sign up by mail, by phone, or on line.

#### When does coverage start?

Coverage is in effect 30 days after the date of enrollment.

#### **Cancellation:**

As per information provided by AWR, the homeowner may cancel coverage at any time. AWR may cancel if notified by DEP that the homeowner is ineligible for coverage or is delinquent in paying his water/sewer bill.

#### Cost:

The introductory prices are in effect through June 30, 2013. They are: \$3.99/month for water lines, \$7.99/month for sewer lines, for a total of \$11.98. They can also be purchased separately. Sales taxes are applicable, but they are included in the introductory rate.

After July 1, 2013, the water line protection cost will increase to \$4.49/month (not including tax), while the sewer line protection will remain at \$7.99/month (not including tax).

After July 1, 2013, a homeowner who has both water and sewer line coverage will pay an insurance cost of \$12.48/month plus 8.875% sales tax, for a total cost of \$13.59/month. This charge would appear on the quarterly DEP Water and Sewer bill as a separate item at \$40.77 (\$13.59 per month X 3 months).

Effective July 1, 2013, the annual cost for both water and sewer line protection, including sales tax, will be \$163.08 (\$40.77 per quarter X 4 quarters).

#### What is covered:

Repair of water and/or sewer lines from wall of house to connection to city main, if damage is due to "normal wear and usage." Accidental damage, and damage due to natural disasters are not covered.

In addition to pipe repairs, the insurance covers "refill, rake and reseed" of any unpaved areas.

Private walkways and driveways will not be replaced with concrete. These areas will be refilled and covered with asphalt. "Public roadways, sidewalks, curbing and driveway aprons will be restored in accordance with the NYC DOT rules and regulations once per occurrence." (Quotations from AWR NYC Sewer Service Line Protection Program Terms and Conditions).

#### What else to watch out for:

According to an article in the Feb 15, 2013 Times Ledger, other companies with similar sounding names are mailing similar sounding offers to homeowners. American Water Resources is the only company approved by DEP.

#### IT'S OK FOR CIVICS TO USE SCHOOLS

Council Member Mark Weprin has notified CCA that he has received assurances from the Department of Education that community groups such as civic associations and tenant groups will be able to continue to meet in public school spaces. The Glen Oaks Village Owners Group had first notified Mr. Weprin back in November of last year that these groups were no longer allowed to meet in public spaces unless they became not-for-profit organizations.

#### 105<sup>th</sup> PRECINCT REPORTS A DECEPTION SCAM

At the February meeting of the 105 Pct Community Council, Deputy Inspector Courtesis discussed a deception grand larceny that took place outside of a bank within the 105th Pct. When a woman walked out of a bank, she was met by a 2-person team. One person, unbeknown to the woman, sprayed shaving cream on her coat to create a distraction. The second person, a man, approached the woman, told her that something was on her coat, and offered to clean it. While cleaning the coat he seemed to have reached into her bag and took the money she had just withdrawn. Similar crimes have been reported in Bayside and Ozone Park.

Some good news: There have been several arrests for burglary in the past month. Burglary rates had started to climb in the beginning of the month, but declined after the arrests. While the precinct will continue to address burglaries aggressively, they will probably continue to be a problem, so continue to exercise caution.

#### THE GRAFFITI FIGHT CONTINUES

A recurring subject in our newsletter has been our attempts to control the plague of graffiti in Bellerose and the surrounding areas. We've spent many hours painting over the "tags" from various vandals. It is common knowledge amongst graffiti fighters that most spray paint is stolen from stores, not purchased. NYC passed a law several years ago requiring retailers to keep spray paint under lock and key. Our local Sears Hardware on Hillside Avenue has been notified several times that their cabinet has been found unlocked and wide open. Last month the NYC Dept of Consumer Affairs also found it unlocked and issued Sears a summons. Hopefully this

will convince management to keep those cabinets secure and help stop providing materials for the creation of more neighborhood graffiti. The paint cabinets were all locked in two separate visits last week.

In a bit of a twist to this story, graffiti has been noticed on the Hillside Ave side of the Sears building.
