### 105<sup>TH</sup> POLICE PRECINT COMMUNITY COUNCIL MEETING HIGHLIGHTS

At the start of every meeting, the precinct commander gives out one or more "Cop of the Month" awards to recognize smart, courageous police work. This past month, Police Officers Bennetucci and McMahon responded to a report of an armed robbery at 3 AM at Merrick Road and 231 St. While interviewing the robbery victim, it was learned that his cell phone was among the items taken. The alert officers tracked the cell phone to a car occupied by two perpetrators, who were arrested. The officers also recovered a gun, stolen items, and two masks used in the crime.

The 105<sup>th</sup> Precinct Detective Squad recently arrested members of a burglary ring that was emptying a house in Rosedale. An alert neighbor called 911. It was determined that the ring was responsible for 12 burglaries in the area. DI Coyle praised the caller, and urged continued community involvement.

PO Daniel introduced himself as the Precinct Domestic Violence Officer. He stated that New York State has a zero tolerance policy regarding domestic violence, and that any case where a criminal domestic crime is reported results in a mandatory arrest. He stated that his unit does follow up visits in cases of elder abuse, and also responds to cases of animal abuse. He can be reached directly at 718-776-9415.

The police officer from the 103<sup>rd</sup> Pct who was attacked with a hatchet has been released from the hospital, but faces a long road to recovery. He has been transferred to the Rusk Institute for Rehabilitation.

The next council meeting will be Thursday, November 20, at 8 PM, at the precinct. Note: This is a change from the normal Wednesday meeting. There will be no Precinct Community Council meeting in December.

#### NEW FINES FOR TEXTING AND DRIVING EFFECTIVE NOVEMBER 1

In NY State, all drivers now face a maximum fine of \$200 for a first-time offense, increased from \$150; a second offense within 18 months goes to \$250 from \$200; and a third or subsequent offense increases to \$450 from \$400, according to the state Department of Motor Vehicles.

Under the law, newly-licensed motorists convicted of texting while driving will have their licenses suspended for 120 days for the first offense. Licenses will be revoked for a year if the offender is found guilty of a subsequent violation within six months of the license being returned.

#### PROPOSED AMENDMENTS TO THE CONSTITUTION OF THE CREEDMOOR CIVIC ASSOCIATION

Note: As per Article IX, Section 1 of our Constitution, proposed amendments must be submitted in writing and read at a regular meeting. They are then tabled until the next meeting, when they are voted on. A two-thirds vote of the members present is required to adopt an amendment.

Article III, Section 4.

Currently: All officers and members of the Board of Governors must reside within the civic area.

Proposed: All officers and members of the Board of Governors must reside within the civic area, with the exception of the President Emeritus.

Article IV, Section 2

Currently: President Emeritus: The title and position of President Emeritus shall be reserved for a Past President of the Association who in the opinion of the general membership is worthy of the title by virtue of outstanding service to the association. The President Emeritus shall be an ex-officio member of the Board of Governors and shall be entitled to full voting privileges. He/she may perform other duties as may be delegated to him/her by the president, and represent the Association at the request of the President. The title is honorary and may remain vacant at the discretion of the membership. Appointment to this position shall be at the discretion of the Executive Board. Only one member may hold the title at a time. The title becomes vacant if the titleholder resigns, or moves from the Association's territory. The term of office shall be one (1) year.

Proposed: President Emeritus: The title and position of President Emeritus shall be reserved for a Past President of the Association who in the opinion of the general membership is worthy of the title by virtue of outstanding service to the Association. The President Emeritus shall be an ex-officio member of the Board of Governors and shall be entitled to full voting privileges while he/she lives within the civic's boundaries. He/she may perform other duties as may be delegated to him/her by the President, and represent the Association at the request of the President. The title is honorary and may remain vacant at the discretion of the membership. Only one member may hold the title at a time. The term of office shall be one (1) year.

Article XI, Section 1 (Meetings)

Currently: Regular meetings of the Association shall be held on the second Monday of each month or as soon thereafter as the Board of Governors deems practicable. No regular meetings shall be held in the months of July and August.

Proposed: Regular meetings of the Association shall be held on the second Monday of each month, unless otherwise determined by the Board of Governors. No regular meetings shall be held in the months of July and August.

#### **ICCC UPDATE**

On October 28, the Indian Cultural and Community Center (ICCC) submitted a "Revised Statement of Facts and Findings" to the Board of Standards and Appeals (BSA). The revised proposal still requests permission to build a four-story building that includes a community center and 57 apartments, on property that the ICCC acquired on the Creedmoor campus. The latest request includes some changes, including a wider emergency access lane, and more planting to provide a barrier between the development and the neighboring homes.

At a press conference held on October 21, 2014, State Senator Tony Avella and the leaders of several local civic associations (including the Creedmoor Civic Association) reiterated opposition to the project.

Another public hearing before the BSA is scheduled for November 25, 2014. More information will be presented at our meeting on November 10.
