L.I. PRESS EDITORIAL BACKS CIVIC PLAN FOR FARM ACRES

Creedmoor Civic Ass'n's proposal to convert the excess farm land at Creedmoor State Hospital into a City-owned tree nursery found a friend at the editorial offices of the Long Island Press, Long Island's oldest and largest daily newspaper. On December 3rd, appeared an editorial entitled, "Community unity with a purpose." It reviewed the plight of Queens communities faced with the prospect of more high-rise construction, and then seroed in on the controversy facing Eastern Queens with 58 acres of buildable land up for grabs with an R3-2 zoning. It then mentioned that "A recent meeting of Community Boards 11 and 13, with several hundred local residents in attendance showed the community had done its homework. One plan, suggested by James A. Trent, president of the Creedmoor Civic Association, and supported by several individuals and groups, calls for use of part of the land as a tree nursery. This would preserve the rural character, as well as provide trees and plants for city parks and serve as a nature laboratory for students in nearby high schools and colleges.

"Mr. Trent also pointed out that his plan is compatible with other proposals, including the use of the 6.6 acre plot for a facility to care for several retarded children... Both (plans) should be expedited."

In addition, the superintendent of the office of high schools of the Board of Education, Mr. Abraham Wilner has written to Community Board 13 to express support. And, Mr. Marvin Weingart, superintendent of Community School District 26(Bayside, Little Neck, Bellerose) also wrote to Community Board 13 to lend his endorsement for the proposal because of the inherent educational value of the plan. Right now Boards 11 and 13 are deliberating on the merits of all the plans submitted at the hearing. President Trent has been asked to submit a cost analysis of his plan and is now working with the Nassau County Cooperative Extension Agents in an effort to come up with the most accurate study.

Esposito Spurs Railroad Meeting

Assemblyman John A. Esposito called a meeting of property owners abutting the defunct Creedmoor Spur of the Long Island Rail Road on December 17th. That was the night of the ice storm, but still some 50+ turned out. The purpose was to discuss resubmitting a bill in the state legislature to mandate the selling of the surplus land to the adjoining homeowners. State Senator Frank Padavan was also present. As a result of the discussion, some modifications of the original bill are being incorporated in the rewriting of the new bill. It is hoped that now with a new governor, we will not be faced with a veto as we were when the bill reached Nelson Rockefeller last time around. The revised bill will still call for selling the land at the original stated price of 20¢ a square foot as suggested by the Long Island Rail Road when they first solicited the property owners in the early spring of 1972.

COMMUNITY REELS IN WAKE OF HOSPITAL EXPOSE

By now all of you have read Senator Frank Padavan's startling revelations about the high incidence of criminal activity on the grounds of Creedmoor State Hospital. Most people had inklings all along of what was going on, but never did we have a total listing over a 20-month period all tallied up for easy digestion. And it's pretty hard to swallow. Particularly when the Hospital and the State tell us that it isn't any different than what goes on outside the Hospital. Well, we beg to differ. The crime rate in northern Queens Village and Bellerose is not the same. But we bring up this issue because we have learned that Senator Padavan has been attacked for making public these statistics. It has been charged that it is not for the best interest of the Hospital, and that it is nothing but a vote-getting gimmick in revealing the sad state of affairs at Creed-

The Creedmoor Civic News does not feel it is in the best interest of anyone to sweep these scandals under the rug, except of course for those who are responsible for its continuing unabated. We support Frank Padavan and are glad that he has vowed to pursue the matter. As it happens, we seem to have more auto thefts and house burglaries on the west end of the civic area, near to 235th Court which leads to Creedmoor Hospital, than we do on the east end, far away from hospital entrances. We wonder what connection there may be. It seems our elected officials are damned if they do, and damned if they don't. We should be glad this has been brought out publicly as there is much greater chance now that something will be It is a terrible thing when food and clothing earmarked for patients is taken by the employees, and other equipment disappears which has been paid for through tax dollars. But worse, are the reports of physical attacks on the patients, and the presence of narcotics peddlers. We hope now, that speedy remedies will be taken by the State Mental Hygiene Department to restore safety and peace to Creedmoor and its pitiful patients.

CREEDMOOR CIVIC COVERED BY NON-SOLICITATION BAN

One of the last acts of outgoing Secretary of State John P. Lomenzo was to sign a blanket order directing real estate brokers not to directly solicit sellers in an area which roughly conforms to the 23rd As-sembly District. This is a large area and is probably the largest such order ever signed in the State's history. In our area the line reaches to Grand Central Parkway and runs east to the City This is good news because it covers a broad enough area so as to cover the problem completely. All it means is that brokers will not call you on the phone, or mail you notices asking you to sell your home. They can lose their licenses if they do. This does not prevent you from seeking the services of a broker if you plan to sell. It's just the "don't call me, I'll call you" philosophy. The signing of this order is an outgrowth of a recent public hearing held in Queens Village on unscrupulous real estate practices which were causing heavy and unwarranted ethnic changes in lower Queens Village and Bellaire.

KINDERGARTEN SHUTOUTS NOW ADMITTED TO '33

The results of the negotiation were that all 10 on the waiting list were to be admitted immediately.

MEMBERS VOTE FOR ZONE CHANGE

Our members unanimously voted to request the City to change our zone from R4 to R3-1, after hearing all comments on the issue. It looks now, however, that our fears concerning the new zone as being overly restrictive were unfounded. Conversions to 2-family will most likely not be as difficult as mentioned in this newsletter last month. It is still up to the City to grant us this request.

PUBLIC HEARING HELD ON CLEARVIEW TRUCKS

A hearing held by the Community Board was held at JHS 109 recently to discuss diverting truck traffic from local Queens Village streets to Francis Lewis Blvd. and Braddock Ave. Creedmoor Civic and Queens Braddock Civic spoke against sending trucks this way, and suggested they be sent east and west on the L.I. Expressway. hadn't been for Councilman Matthew Troy, we would not have had much to say on the issue. The matter not have had much to say on the issue. however, is still unresolved, since the State refuses to deny trucks the right to use Clearview up to its terminus at Hillside Avenue.

REMEMBER THE MAIN

Remember our new 18-inch water main each time you ride down bumpier-than-ever Braddock Avenue. The repaving contract was to have begun in November, but was held up pending the Dept. of Water Resources contract for a new water main running from Cross Island Parkway to Winchester Boulevard. Over a year ago, Creedmoor Civic wrote to the City and suggested a new line was needed since breaks were occurring at the rate of about one a month. City apparently agreed with us. However, the Braddock work which was to have been done in two contracts about a year apart, will most likely go with the two contracts being carried out simultaneously, so we really are not losing much time. Jim Trent has examined the plans for the paving at the offices of the Highway Department. taking bids now. The mall will contain turn-off lanes for cars making left-hand turns, and trees will be planted along the curbs wherever possible. Trees will not be planted in the mall because of poor survival rate experienced with similar projects in the past, Winchester Blvd. being one of them. A triangle will be built at the intersection of Braddock and Gettysburg to help facilitate . the flow of traffic. Further discussion on this will take place at our meeting.

PONTIAC, MOLINE STREETS TO GO IN '74

A contract is now being prepared for the '74-75 capital budget to reconstruct Pontiac and Moline In addition, the intersection of 235th Streets. Court and 88th Avenue will be completely realigned --when finished will bear little resemblance to the Picadilly Circus madness that goes on there now with cars coming from all directions with many accidents and near-accidents. Details will be given on this at our meeting also. Other than these two streets, no others are planned for any work in the forseeable future.
