# CITY PLANNERS ZONK TREE FARM, COMMUNITY GIRDS FOR BATTLE

Another Forest Hills style community-City confrontation appears to be looming as eastern Queens learns that the City Planning Commission does not care to consider itself bound by the decision of the joint committee recommendation of Community Boards 11 and 13 concerning the disposition of the 52 surplus acres at Creedmoor State Hospital.

Thanks to the continuous needling by an editor of the Long Island Press, who informed the City Planning Commissioner that they had more than enough time to study the issue, it was finally revealed that they had ideas of their own concerning the use of the property. Specifically they wished to allow the construction of 900 dwelling units of housing on 30 acres, and allow the remaining 22 acres to be used for an undetermined kind of recreation. City Planning blamed the Park Department for the demise of the tree farm-educational complex the community wished to see located there.

Reaction by community leaders was swift and vociferous. "Over my dead body," reacted angry State Senator Frank Padavan. Mrs. Sue Noreika, chairman of Community Board #13 vowed that "the gloves were coming off." James Trent, president of Creedmoor Civic Association and originator of the plan that was finally adopted by the Community Boards charged that the CPC was "irrelevant", and threatened to see to it that the central Planning Commission was abolished as it is now constituted, and have it replaced with Borough Planning Commissions, responsible to the people. "I don't know who they are working for," Trent charged, "but they certainly aren't working for the people of eastern Queens." Contacted by the Long Island Press, Trent also indicated that a meeting between the Commissioner of Parks and the Community was necessary since the Planning Commission blamed the Park Department for killing the plan. He also indicated that a meeting with Mayor Beame was also being considered.

Despite the general gloom and pessimism that prevailed over the Press revelation, Trent said the issue was far from lost and told the L.I. Press that eastern Queens had the power, resources and the wherewithal to over-ride the Planning Commission and insure that the plan would come to fruition yet.

"We have the legislators on our side", Trent remarked, referring to Sen. Padavan, Assemblyman John Esposito, and City Councilman Matthew J. Troy. "In addition we have been backed by Martin Van Buren High School; the Queens Historical Society; NATURE; the New York City Board of Education; the superintendent of District 26, Marvin Weingart; by political leaders; and by dozens of civic groups from Little Neck to Queens Village. These people deserve to be listened to, especially after the City saddled us with the monstrous North Shore Towers," Trent concluded.

#### SPUR BILL NOW SPUR LAW

We are all elated over the fact that Gov. Wilson has seen fit to sign the bill authorizing our homeowners on 88th Ave. to buy the railroad land behind their homes for 20¢ per sq. ft. Soon a canvas will have to be made to determine who is buying and who, if any, is not. We don't expect the railroad to do this for us since the bill provides that if the deal is not consummated by Jan. 1, 1976, the railroad is released from the obligations of the law, and can auction it off as they originally wanted to. Our thanks to Sen. Padavan and Assemblyman Esposito for their aid on securing the law for us.

#### A NEW KIND OF BUSING PLAGUES OUR TOWN

The sad news has finally been released concerning our new T.A. bus garage on 222nd St. They will house 216 buses(at least that's what they're admitting to), and of these 121 will use Springfield Blvd. as their means of feeding the bus routes. Only 15 are expected to use Braddock Ave., which is about all we have on the Q-1 Bellerose route anyway. Nevertheless, we will all suffer from the pollution which will descend upon us depending on how the wind blows. The battle with the T.A. over pollution control is not over, as Councilman Matt Troy is still holding \$1,000,000. up from the T.A. budget until they comply with our demands. We are now studying the routes to see if any changes, particularly for Springfield, can be made to alleviate the burden on any one community. The garage is expected to open in September.

#### CIVILIAN PATROL RECEIVES INTRUSION ALARMS UNDER BLOCK SECURITY PROGRAM

Our Creedmoor Civilian Patrol, under the leadership of William Mattis of Moline Street, has finally received some of the equipment we requested last July under the grant program between the City of New York and our Civic Association. Four sonic intrusion alarms have been deliverd to our patrol. As we explained last year, any resident planning to go away may request an alarm be installed in his home. If anyone breaks into the home and crosses into the range of the alarm, the alarm will be activated and sound off from a horn which will be afixed to the exterior of the house. The general scheme is to leave a key with a trusted neighbor. When the horn sounds, the neighbor will call the police. police arrive, the neighbor will give them the key so they can enter the house. No neighbors are expected to do anything other than call the police. If anyone wants to make use of this apparatus, should call Bill Mattis at HO 5-5889.

Also secured are several special flashlights for the use of the patrol. These also came about through the matching program with the City. Receipt was also made of the two-way radios and walky-talky equipment but was deemed by all the patrols of the 105 to be inferior to what was originally requested. The equipment was returned and a new shipment is expected shortly of much better instruments.

Our Civilian Patrol was also scheduled to receive a citation for excellence in performance. The ceremonies were postponed from last May 22 and will be rescheduled soon. Our hats off to the men and women of our patrol for work well done, especially to our tireless chief of patrol, Bill Mattis. In such short time our patrol has become the envy of many other In such short civic associations.

# Braddock Ave. Phase 1 Contract Awarded

To the early Americans, it was the Road to the Rocky Hill, to the jet set Americans it is the Rocky Road to the Hill. Well, Bellerose natives will be over-joyed to learn that Rocky Hill Road, since renamed Braddock Avenue has moved one step closer to being paved. Commissioner Dan Garvey of the Highway Department informed us that Phase One contract has been awarded to Mascali. been registered with the Comptrollers office, and work should start by June 15. Phase One will run from Fairchild Funeral Home south to Moline St. Phase Two will be advertised shortly, and will pick up at Moline St. and run south to Cross Island Southbound Service Road. Braddock Phase Three includes Pontiac St., Moline St., and the intersection of 235th Ct. and 88th Ave. No date has been set for phase three yet. Comm. Garvey complained that the money for Phase I had been taken away, and he had to fight to get it back. This partly explains for the delay. He complained further that it seems this job has been "jinxed" from the start, since it is about three years behind. Unfortunately, we learned that the trees originally promised for the center mall have been deleted because trees in this type of situation do not survive well. However, curbside trees will be planted wherever possible. If necessary, we might prevail upon the Park Dept. in the future to plant the mall trees, but for now we'll be content with just getting a new road bed and treeless mall. We could also explore decorating the mall with plant pots which the civic associations would then have to keep planted and maintained.
