We are pleased to announce that Mr. Maurice J. Freeman, manager of the Jamaica Branch of the Home Owners Loan Corporation, has consented to address us at our next meeting, Tuesday Evening, October 3rd.

Mr. Freeman is in charge of the distribution of Federal funds to be granted to home-owners who are experiencing difficulty in their negotiations with the holders of mortgages on their homes.

He will explain the workings of the Federal

Home Loan Act, give the procedure necessary to obtain a loan and will answer any question on the subject.

**TRIBORO BRIDGE**

The Triboro Bridge Authority is hard at work shaping up the legal requirements of this gigantic project. Technicalities have arisen in the matter of acquiring title to the land needed for the arterial approaches to this bridge and not until title has been finally vested in the Triboro Bridge Authority will the Federal Government advance the \$35,000,000 loan and \$7,000,000 grant, although about \$100,000 has already been given to reimburse for preliminary outlays.

George Gordon Battle, of the Authority, feels though, that these delays will not interfere with advertising for bids on the contracts and he hopes actual work on the bridge will start about November 1st.

**THIRD RAIL**

At a meeting of residents of the area between Floral Park, Queens, and Hillside Ave. held at the meeting rooms of the Creedmoor Civic Assn. protesting the hazards of the third rail of the L. I. R. R. on the Creedmoor spur, it was decided to place the entire matter in the hands of the United East End Civic Associations.

The residents of our community responded splendidly when asked to sign the petitions that were circulated. These were handed over to the United East End Civic Assns. and will be included with those of our neighboring communities for presentation to the proper authorities.

**FOOTBALL**

The football season in our community opens Sunday, October 1st, with the Colony Football Club playing at Colony Field, 244th Street and 85th Avenue and the Bellerose-Lormawood Football Club opening its season on Oct. 8th at Smith's Field, Rocky Hill Road and 222nd Street.

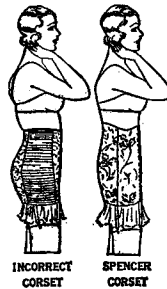
