# FOOD CHAIN NIXES

# BELLEROSE STORE IDEA

Refusing to toss in the towel after Creedmoor Civic's unsuccessful bid to keep the Great A & P Tea Company from leaving town, Creedmoor Civic president, James Trent, contacted the Associated Food Store headquarters in Jamaica in the hopes of attracting a franchise into our area.

A spokesman for Associated Cooperative, which doesn't own any of its own stores, but gives franchises out to individuals wishing to use their name, indicated that the food chain business is very bad what with more and more government regulations and taxes, the profit margin has become increasingly slim. To open a store in our area at about 5,000 square feet would cost over \$200,000. excluding the cost of stocking. Now with the sales tax in New York City 1¢ higher than in Massau County, the spokesman indicated he could not in conscience recommend to a prospective franchisee to locate in our area.

Creedmoor Civic contacted Associated because the vice president at A & P indicated that their old store, now the site of martin Paint, could have operated profitably if it were a family operation, but Associated denied that a family operation could make out any better. Now with Bohack on the rocks, the prospect of finding any food chain to locate in the downtown section of Bellerose, looks dimmer still.

## QUEENS VILLAGE PARKING FIELD

The site selection board has approved the site of the bombed-out Queens Village O.T.B. at 218th Street and Jamaica Avenue for a municipal parking field. The project will commence as a field with provision for future vertical expansion. This appears to be a reversal of the City's original committment to build stores on the first floor with parking on the roof. Meanwhile, the plot thickens as Councilman Matthew J. Troy fires off a letter to Burger King and the Padigen Construction Corp. warning them not to go ahead with plans of building a hamburger restaurant on the site. Troy warned of condemnation proceedings and a lawsuit by the City if they proceed.

TREE FARM VICTORY CRYSTALIZES

By now all have read of the City Parks Departments reversal on their interest on the 52 surplus acres at Creedmoor State Hospital. Now they would like not only the 40 acres we offered, but all 52 if we would give it They plan a horticultural test center, with provision for visitation by the public, recreation, and further provision for use of the site by the Board of Education and Queens College. Right now the Parks Department is finalizing their specific requirements. The community will then review the Parks plans for approval. Price of the land is still not settled, but the State informs us that until we have a final plan of action, they cannot determine what price they will ask. they say, is determined on how well a use we put the land. At this point it looks as though the community is successful in preventing any construction on this prime farmland. The City Planning Commission backed off quickly after the stinging reaction of civic leaders when the plan for 900 units of housing was revealed by the L.I. Press.

BRADDOCK PHASE 2 contract which will complete Braddock Avenue repaving from Moline Street to the southbound lanes of the Cross Island Parkway service road has been delayed. Originally expected to get under way in August, projection is now early fall. Meanwhile, work is progressing swiftly on Phase 1 from Springfield Blvd. to Moline Street. Two hundred feet of storm sewer has also been installed because Pontiac Street was lacking a sewer to pick up water at its intersection with Braddock Ave.

Creedmoor area residents, already staring up at Sigmund Sommers' elephants at Glen Oaks understand what the battle is all about.

### HOW CREEDMOOR GOT ITS NAME

(Condensed from The Story of Queens Village by Vincent F. Seyfried)

On July 8, 1872 a deputation of militiamen visited the Creed Farm to check on its suitability for a parade ground. Curiously, the area had as yet no name other than Queens. One of the directors of the National Rifle Association, H.G. Shaw, in a book entitled, "Pacific Life", tells how Creedmoor got its name:

"The next day the directors were to meet and I felt that I ought to have a name to suggest. Suddenly, it occurred to me that it would be a good idea to call it after Creed(B. Hendrickson Creed, former owner). So I jumped up, struck a light, and scribbled off with a pencil the words Creeding, Creedam, Creedville, Creedum, Creedom, Creedmont, Creedshot, Creedflat, Creedplain, Creedfield, Creedmarsh, Creedmoor. I returned to bed and fell asleep with a fixed resolution that I would next day submit some one or the other of the above names. At breakfast, I settled upon "Creedmoor" as the most breezy and euphonious word. I wrote the same in Roman characters on a piece of paper in order to impress the eye as well as the ears of my associates. I showed the name to Wingate (secretary of the Rifle Assn.), but he did not seem to fancy it. When the question came up at the meeting, I suggested Creedmoor. It sounded like so much Greek to the board, for after the paper upon which I had written the now famous word had passed around, it was quietly dropped on the table. I said nothing and did not join in the half hour's discussion which followed during which several other names were suggested. Nearly every gentleman present had some pet name to propose but none would yield to the other. Finally someone moved that the question of naming the range be postponed. Then Major George Moore Smith of the N.Y. 7th picked up my card, turned it over once or twice and said he didn't see why Creedmoor was not as good a name as any that could be thought of. Mr. Alexander W. Craven wanted to know what it meant, and upon my informing him, he thought that the name Cont'd on Page 6

# WOULD-BE SPUR OWNERS TOLD TO SIT TIGHT

To those residents of 88th Avenue who think we've forgotten them, the answer is we haven't, but we are not ready to make any moves just yet. Assemblyman John Esposito has met with the Long Island Rail Road and papers are in the process of being drawn up which will permit the adjacent homeowners to take possession of their land.

A meeting will be called of all spur-interested families, not only of Creedmoor Civic, but of the three other civic associations involved as well.

Currently thinking calls for hiring one surveyor for all 191 property owners and sharing the cost among them all. This will save each family much money and speed up the transfer of land. Commitees will be formed from each civic group to take Committone final canvas to find out who is buying and who is not interested. Then we will determine who among the adjacent homeowners will purchase the parcel that was rejected by the homeowner who adjoins it.

would be the very thing. Then the others called for a reading of the word, and after each had pronounced it for himself two or three times, Creedmoor was, I believe, unanimously adopted as the title. This was at a meeting of the directors held on the 23rd of July, 1872. The name appeared in the "New York Sun" on the following day. This was the first time the name ever appeared in print anywhere."
